TERMS & CONDITIONS

1. DEFINITIONS

- 1.1 The following words and expressions shall have the following meanings unless the context indicates otherwise:
- **"Advance Payment"** means the advance fee payable by the Client to the Agent in respect of the Booking.
- **"Agent" & "Agency"** means OraModeling.com, a freelance marketplace for models and talents.
- **"Agent's Services"** means the services supplied by the Agent, including facilitating connections between Clients and Talents.
- **"Agreed Usage"** means the permitted use of the Images as specified in the Booking Form.
- **"Agreement"** means the contract between the Agent and the Client for the provision of Services incorporating these Terms and Conditions.
- **"Booking"** means the arrangement for the Talent to provide modeling or entertainment services.
- **"Booking Form"** means a document outlining the agreed-upon details of a Booking.
- **"Client"** means any entity or individual purchasing Services from the Agent.
- **"End User"** means the entity utilizing the Talent's services.
- **"Fee"** means the amount payable by the Client to the Agent for a Booking.
- **"Images"** means photographs, videos, or other visual representations of the Talent.
- **"Services"** means the modeling or entertainment services provided by the Talent.
- **"Talent"** means a model, actor, performer, or other individual offering services through the Agency.
- **"Terms and Conditions"** refers to this document.
- 1.2 These Terms and Conditions apply to all Bookings and supersede any other documentation.
- 1.3 Any modifications to these Terms require written approval by both parties.

2. BOOKINGS

- 2.1 A Booking Form must be completed and signed before the Talent provides Services.
- 2.2 Fees stated in the Booking Form are estimates and may be subject to adjustments based

on the actual scope of work.

2.3 Additional charges may apply if the Client requests modifications to the original Booking.

3. SERVICES

- 3.1 The Services will be described in the Booking Form and must not be altered without mutual agreement.
- 3.2 The standard working hours for a Booking are:
- Full day: 8 hours
- Half day: 4 hours
- 3.3 If minors are booked, the Client must comply with child labor laws in Egypt and ensure appropriate supervision.

4. USAGE RIGHTS

- 4.1 The Client may only use the Images within the agreed-upon scope.
- 4.2 Usage rights become valid only after full payment of Fees.
- 4.3 Any additional usage beyond the initial Agreement must be approved and may incur extra charges.

5. PAYMENTS

- 5.1 Payments must be made in full before the Booking unless otherwise agreed.
- 5.2 Overtime rates apply for bookings exceeding agreed-upon hours.
- 5.3 If a third party is responsible for payment, the Client must notify the Agent in advance.

6. CANCELLATIONS

- 6.1 Cancellation fees apply as follows:
- Within 24 hours: Full Fee payable.
- 24-48 hours before the Booking: 50% of the Fee payable.
- 6.2 If the Talent cancels, the Agent will attempt to find a replacement.

7. CLIENT RESPONSIBILITIES

- 7.1 The Client must ensure a safe and professional working environment for the Talent.
- 7.2 If the Talent is required to wear specific clothing or costumes, they must be clean and appropriate.
- 7.3 The Client must provide adequate changing facilities.
- 7.4 Any mistreatment of Talent may result in the immediate termination of the Booking without a refund.

8. LIABILITY

- 8.1 The Agent is not responsible for any damages or losses incurred by the Client due to a Talent's performance.
- 8.2 The Client is responsible for any damages to the Talent's property or well-being during the Booking.

9. GOVERNING LAW

- 9.1 These Terms and Conditions are governed by the laws of Egypt.
- 9.2 Any disputes shall be resolved in the courts of Egypt.
